- 1. The Vendor must have valid PAN and GST registration.

- 5. The bidder should have a sales and/or service office in India (preferably in Gujarat State, Ahmedabad or Gandhinagar) that has been operational for more than 3 years as of tender floating date.
- 6. Copies of any of the:- Property Tax Bill / Electricity Bills / Telephone Bill / Valid Lease Agreement should be submitted with the bid confirming the time period of more than 3 years as on tender floating date.

Terms & Conditions

- 1. Bidder needs to quote composite rate i.e. CGST + SGST + CESS or IGST + CESS as the case may be. Any changes in Govt. Taxes / Duties would be applicable as on actual at the time of invoice processing.
- 2. Necessary statutory deductions, in accordance with rules as applicable, may be deducted at source by GIPL from the above quoted amount.
- 3. The quoted rate is inclusive of all lodging, boarding, travelling charges as may be required during the tenure of execution of the project.
- 4. Licenses subscription shall be procured in the name of GIPL.
- 5. GIPL reserves the right to cancel this requirement without assigning any reason.
- 6. The final decision however on selection of the vendor will be at discretion of the competent authority of GIPL.
- 7. Delivery Period: On immediate basis.
- 8. Payment Terms: Payment will be paid by GIPL, after successful implementation basis of licenses. Payment will be processed against raise of invoice, Payment will be paid by GIPL within 45 days after successfully implementation.
- 9. Evaluation of quotation shall be based on the Total Cost to the Company. The quotation that complies with all of the requirements and offers the lowest price shall be selected. Any offer that does not meet the requirements shall be rejected.

- 11. Governing Laws & Jurisdiction: The resulting engagement shall be made under, and shall be governed by and construed in accordance with the laws of India and will be subject to exclusive jurisdiction of courts in Gandhinagar, Gujarat, India.

- 1. Must include full technical support regarding access to plugin feeds and updates for Nessus Professional, and patches/upgrade paths for Burp Suite Professional.
- 2. Vendor must ensure operational support (installation and troubleshooting) is available.
- 3. An escalation matrix and a designated SPOC/ Account Manager are required for further communication.
- 4. Vendor must certify that licenses are sourced through an authorized reseller/OEM channel.
- 5. The buyer reserves right to conduct an audit or direct verification with OEM during contract term.
- 6. Vendor must deliver activation keys and provide step-by-step installation documentation within 7 business days of contract award.
- 7. Activation must be completed and confirmed in writing by both Buyer and OEM within 7 business days of delivery.
- 8. Licenses must be OEM-sourced, genuine, and covered under official OEM licensing terms (Port Swigger, Tenable).
- 9. Deployment must be on premise, with local installation and offline/online activation.
- 10. License validity: 12 months, including full access to technical support and product updates.
